

TERMS OF REFERNCE FOR LINDA HAKI-CHILD RIGHTS ADVOCACY AND SHG

Background info.

Ripples International Trust (RI) is a not for profit Christian, indigenous Kenyan Civil Society organization founded in 2002. RI is a child rights organization committed to serving children through community focused initiatives in partnership with stakeholders as inspired by the teachings of Jesus Christ. The organization seeks to protect and promote respect for the rights of women and children.

Ripples International started out its operations by carrying out community HIV awareness in County and supporting children and families affected and infected with HIV. This led to the establishment of a baby rescue centre known as New Start Centre in 2004 to cater and provide care and support for babies orphaned due to HIV and those completely abandoned. RI programs soon expanded and diversified to support orphans and vulnerable children living with their caregivers at the community level, rescue and shelter for girls and women who have suffered gender based violence or at risk of violence. Since then over 16,000 children from 9000 families have benefited from RI initiatives in Meru, Isiolo, Samburu and Tharaka Nithi counties with over 2 million members of the public reached with child rights prevention and intervention education messages.

Description of project being evaluated.

The purpose of this terms and reference is to provide a framework for planning and conducting the final evaluation for the Linda haki-Child rights advocacy and SHG project funded by Kindernothilfe- KNH. The final evaluation will use both Quantitative and Qualitative methods to ascertain the impact of the project. It will also assess what factors enhanced and/or limited achievement of project targets as well as documentation of the results achieved and lessons learned for future programming. An external evaluation will provide a view of the project that is considered more objective by intended users. The staff of RI, beneficiaries, partners, stakeholders will be involved to have their voices heard. An external evaluation will be perceived as more credible, unbiased and objective for relevant parties.

The prevalence of childhood violence remains high, affecting nearly half of female and more than half of male as per the Violence against children report of 2019.

Physical violence is the most common form of childhood violence affecting nearly 2 out 5 females and half of males, most commonly perpetrated by parents and caregivers. The survey also found that nearly half of females and males witnessed physical violence in the home in their childhood.

The prevalence of violent discipline including corporal punishment and psychological aggression against children was also found to be high affecting almost half of females and 4 out of 10 males. Nearly, 1 in 6 females experienced childhood sexual violence and a lower percentage of males experienced childhood sexual violence.

Retrogressive cultural practices such as FGM and child marriage continue to be rampant in the country with about 5% of children being at risk of such practices. Violence was found to significantly affect mental health in children.

Poverty has been rated as the most common root cause of violence against children as it prevents parents and caregivers from adequately providing for their children need and well-being. Children also escape harsh environment at home and end up being exploited either in streets or by perpetrators.

The project Linda haki-Child rights advocacy and SHG in partnership with the county governments of Meru and Isiolo, national government line ministries and other likeminded stakeholders have been responding to the challenges preventing children from enjoying full rights since June 2017. This has been through empowering of duty bearers through training and capacity building in order for them to fulfill their duties and on the other hand empowering right holders to claim for their rights.

The project has also created awareness through design and distribution of IEC materials, public barazas, use of mainstream, print and social media, drawing of child rights murals and Child rights clubs in schools. On intervention, the project has been steadfast in rescuing, rehabilitating and re-integrating children survivors of abuse.

In efforts to address the root causes of child abuse i.e. Poverty, the project has implemented an economic empowerment project known as the Self-help group Approach in Akithi and Athwana wards of Tigania West Sub County in Meru County with a view of improving the wellbeing of children.

The objective has been to reduce the incidences of child abuse cases in Meru and Isiolo counties by 40%.
